- **Sodium PCA,** Natural mineral salt used as a humectant. Increases the water content of the top layers of the skin by drawing moisture from the surrounding air.
- **Glycerin,** is used as a moisturizer to treat or prevent dry, rough, scaly, itchy skin and minor skin irritations.
- **Betaine,** is involved in cell protection against oxidative stress through the so-called "osmolite strategy". Betaine has a good anti-inflammatory action on superficial inflammatory lesions.

- Arctium Lappa Root Extract, helps protect against chronic tissue inflammation and stimulates collagen synthesis. Promote blood circulation to the skin surface, improving the skin quality/texture and curing skin diseases like eczema.
- **Scutellaria Baicalensis Root Extract**, it is apparently effective in treating acute and chronic dermatitis . It's main function as anti-inflammatory, anti-oxidative and anti-irritant.
